**A**fter a good start in 2018, the efforts to establish a solid and sound foundation of the ASEAN-IPR Secretariat governance and administrative support was strengthened by the holding of the first external audit of the Institute in 2019. The findings of the external audit saw the financial management as healthy, sound and credible. This has shown the capacity and reliability of the ASEAN-IPR Secretariat to fully manage its own operational funds, as well as project funds, starting from January 2020.

The ASEAN-IPR in 2019 continued to show enthusiasm and dynamism with the holding of a number of activities. These activities covered the completion of a research project, more activities focusing on the role of women in peace processes, capacity building for officials of ASEAN Member States (AMS) as well as reaching out to ASEAN External Partners and related Institutions of Excellence. Likewise, the Institute has produced its own Communication Strategy and Work Plan, to ensure deeper engagement and wider outreach in its work.

In bringing the crucial role of women in peace processes forward, the ASEAN-IPR convened the first ever ASEAN Women Interfaith Dialogue in November, taking on the theme “Promoting Understanding and Inclusivity” with Indonesia taking the lead. The Dialogue brought together members of the ASEAN Women for Peace Registry (AWPR), women religious leaders and women peace activists to share and find ways and means to deal with today’s challenges faced by the region.

As part of the Institute’s function to pool of expertise in the region, the first leg of the ASEAN-IPR Training Series entitled ‘Mainstreaming Peace and Reconciliation in Southeast Asia’ was conducted in Manila in February, led by the Philippines in cooperation with the Ateneo de Manila University, with support from the Republic of Korea (ROK). The 1st Leg took the theme “Approaches in Peace Process and Peace Building in Southeast Asia and the Role of Mediators”. We are looking forward to the subsequent Legs of this Training Series to be conducted in Myanmar in 2020, and Lao PDR in 2021.



A significant milestone in 2019 was the completion of the very first ASEAN-IPR research project. The “Lessons Learned from a Process of Conflict Resolution between the Government of the Republic of the Philippines (GRP) and the Moro national Liberation Front (MNLF) as Mediated by Indonesia (1993-1996)” is now a full-fledged publication of the Institute, of which its launch Seminar was attended by key-players in the negotiation – both from the GRP, as well the MNLF, and also the Indonesian facilitators. The Seminar thus provided the audience deeper understanding of the negotiation and facilitation process from a first-hand point of view.

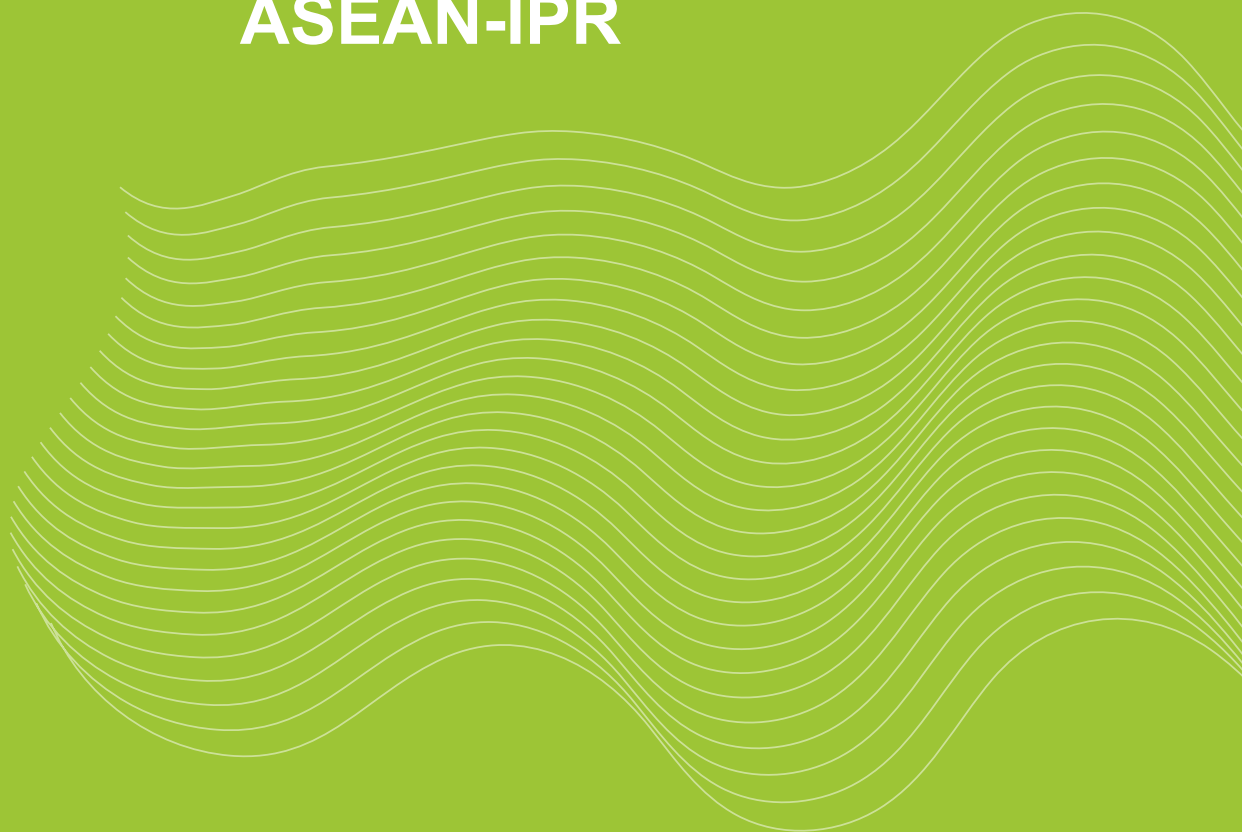
Reaching out and networking functions of the ASEAN-IPR continued in earnest by the conduct of a study visit of the ASEAN-IPR to Switzerland, upon invitation by the Swiss Federal Department of Foreign Affairs (FDFA), where Members of the Governing Council, Advisory Board, and the Secretariat engaged with both government and non-governmental institutions in Switzerland to share experiences on best practices and lessons learned on peace facilitation and reconciliation. Moreover, in the past year the Institute has also engaged with Crisis Management Initiative (CMI) in Helsinki and the Clingendael Institute in The Hague, to look into possibilities of collaboration with the like-minded institutions. Attention to the ASEAN-IPR was also given in the ASEAN-UN platform, through the Regional Dialogue on Political-Security Cooperation (AURED) – which specifically looked into how the Institute’s function in pooling expertise could be developed and fulfilled.

I would like to take this opportunity to convey my acknowledgement to Thailand for its many achievements during its Chairmanship in 2019. Furthermore, I would also like to express my highest appreciation to the Governing Council and Advisory Board for their continued guidance. My appreciation also goes to ASEAN-IPR’s partners and stakeholders for their support and collaboration in the past year.

The ASEAN-IPR Secretariat is happy and truly encouraged to see that 2019 was a year of many firsts – whether through activities, milestones and achievements. We look forward enthusiastically to 2020, with Viet Nam as our Chair and lead shepherd, and the years beyond for more Initiatives and activities in the fulfilment of the mandate of the ASEAN-IPR to contribute to the ASEAN community-building.

# Establishment



## ASEAN Institute for Peace and Reconciliation

The ASEAN Institute for Peace and Reconciliation (ASEAN-IPR) is an Institute mandated to be ASEAN's institution dedicated for research activities, and supporting ASEAN bodies, on peace, reconciliation, conflict management and conflict resolution.

The Institute was established in fulfilment of an action line under Provision B.2.2.i of the ASEAN Political-Security Community (APSC) Blueprint (2010-2015), which aims to “*strengthen research activities on peace, conflict management and conflict resolution*”.

On 8 May 2011, at the 18<sup>th</sup> ASEAN Summit, ASEAN Leaders adopted a “Joint Statement on the Establishment of an ASEAN Institute for Peace and Reconciliation”. The following year, at the 45<sup>th</sup> ASEAN Foreign Ministers Meeting (AMM) in July 2012, the Institute's terms of reference (TOR) was adopted, making way to the Institute's official launch during the 21<sup>st</sup> ASEAN Summit on **18 November 2012** in Phnom Penh, Cambodia.

The Institute's legal personality is established under a Host Country Agreement with the Government of the Republic of Indonesia, granting the ASEAN-IPR's privileges and immunities, which was signed on 1 February 2018.

In addition to being a research institution, the Institute is also occasionally called to promote activities agreed in the APSC Blueprint, and additional activities as agreed by ASEAN Member States. Specifically, the Institute has been assigned to be one of the implementors of **10 Action Lines under the APSC Blueprint 2025**.

# Mandate & Functions

Pursuant to its mandate, the Institute is to undertake activities as prescribed in its **Terms of Reference**, available in **ANNEX 1**, which include:

## RESEARCH



Undertake **research** and compile ASAN's experiences and best practices on peace processes, with a view to providing appropriate recommendations to ASEAN bodies, and enhance regional mechanisms

## CAPACITY BUILDING



**Build capacity** and knowledge on peace processes for all stakeholders

## POOL OF EXPERTS



Develop a **pool of experts** to assist ASEAN (governments and/or Bodies) in conflict management, provide policy recommendations, as well as facilitation for peace negotiations

## NETWORKING



Establishing **linkages/network** with relevant institutions and organisations in ASEAN Member States, as well as other region, and at the international level with similar objectives aimed at promoting a culture of peace

## DISSEMINATION OF INFORMATION



**Disseminate information** of best practices, lessons learned and relevant information to ASEAN Member States, other relevant stakeholders, as well as the general public

# Structure of the ASEAN-IPR



The ASEAN-IPR consists of:

## Governing Council (GC)

**The Governing Council (GC)** is the highest decision-making body of the Institute, with the responsibility to formulate guidelines and procedures for the Institute's activities, as well as approving the Institute's annual operating budget. The GC consists of one representative from each ASEAN Member State, with the Secretary-General of ASEAN and the Executive Director of ASEAN-IPR (serving as Ex-Officio Members of the Council).

## Advisory Board (AB)

**The Advisory Board (AB)** is responsible for generating research priorities of the Institute, for consideration by the Governing Council. The Board consists of eminent persons in related field, with one representative from each ASEAN Member State.

## Executive Director (ED)

**The Executive Director (ED)** represents the ASEAN-IPR in all administrative and operational matters and manages activities of the Institute. The ED also heads the ASEAN-IPR Secretariat, based in Jakarta. The Institute's first Executive Director is **Mr. Rezlan Ishar Jenie**, who was appointed by the Governing Council on 17 October 2017, for a three-year term.

From its official inauguration in 2012 until October 2017, prior to the appointment of its first Executive Director, activities of the Institute have been ASEAN Member State-driven. In other words, the Institute existed through activities under its framework, which were initiated by the Governing Council and/or Advisory Board – many of which were in collaboration with relevant partners and/or stakeholders.

## ASEAN Women for Peace Registry

Pursuant to the Institute's function to pool expertise in support for ASEAN's peace and security efforts, the ASEAN-IPR established the ASEAN Women for Peace Registry (AWPR) on 13 December 2018 in Cebu City, Philippines. The AWPR is a means to take stock of the knowledge of its women experts in the field of peace and reconciliation. The AWPR also aims to contribute to the implementation of the ASEAN Leaders' "Joint Statement on Promoting Women, Peace and Security in ASEAN", adopted on 13 November 2017 during the 31<sup>st</sup> ASEAN Summit, which encouraged the integration of gender perspectives in all conflict prevention initiatives and strategies.

The ASEAN-IPR annual operational budget for the first three years (2018-2020) of operation is provided through the generous contribution of the Government of Indonesia, in the amount of **USD 272,580** per-annum. The utilisation for the operational budget of 2019 is at the rate of approximately **seventy-five percent (75%)**.

In 2019, the Government of Indonesia continued its support for the ASEAN-IPR Secretariat's office in Jakarta, as part of its commitment to bear the Secretariat's operations during the first three years. In addition, in-kind contribution of office equipment and supplies, operational vehicle and basic maintenance were also provided.

As a symbolic of goodwill in its chairmanship year of ASEAN in 2019, the Government of the Kingdom of Thailand accorded a one-off contribution for the operations of the ASEAN-IPR, in the amount of **USD 16,321.20**.

## External Audit and Outcome of Audit

The ASEAN-IPR engaged Independent Auditor BDO Indonesia (*Tanubrata Sutanto Fahmi Bambang & Partner*) between February-May 2019, to audit the Institute's annual operational budget and project funds for the period of 1 June 2017 to 31 December 2018.

The Independent Auditors were satisfied that the accounts presented fairly on the Institute's finances. Noting such performance, the GC approved for the Institute's operational funds to be fully administered by the ASEAN-IPR Secretariat per 1 January 2020.



# ASEAN-IPR Activities in 2019

The ASEAN-IPR's activities are pursuant to its Three-Year Work Plan (TYWP) 2018-2020 – which was formulated to guide the Institute in implementing its mandates and functions.

Accordingly, the TYWP aims to define targets and achievements on the TOR and to chart out strategic direction and outcomes for the Institute. The TYWP 2018-2020 is available as [ANNEX 3](#).

The following are highlights of the Institute's activities throughout 2019.



## **Preliminary Seminar on the ASEAN-IPR Research Project on Lessons Learned from a Process of Conflict Resolution between the Government of the Republic of the Philippines (GRP) and the Moro National Liberation Front (MNLF), as Mediated by Indonesia – 1993-1996**

*7 February 2019 - ASEAN-IPR Secretariat, Jakarta, Indonesia*

The Seminar marked the start of the Institute's first ever Research Project. With 40 participants coming from government (including some Members of the GC and AB), academes, civil society and media, the Seminar introduced the first steps of the Research Project (including to determine direction and methodology of the research), as well as initial findings of the research. Amongst the objectives of the research, are to (i) evaluate policies and strategies carried out by the GRP and the MNLF, and (ii) assess the Final Peace Agreement between the two, particularly on whether it has successfully addressed the problem of secessionism. The Research Project is **spearheaded by Indonesia**, and supported by the Japan-ASEAN Integration Fund (JAIF).

### Leg 1 of the ‘Mainstreaming Peace & Reconciliation in Southeast Asia: an ASEAN-IPR Training Series’ – “Approaches in Peace Process and Peacebuilding in Southeast Asia and the Role of Mediators’



21-22 February 2019 - Manila, Philippines

Pursuant to the Institute’s capacity building and pool-of-expertise function, **Permanent Mission of the Philippines to ASEAN, the Office of the Presidential Adviser on the Peace Process (OPAPP) and the Ateneo de Manila University**, with the support of the ASEAN-Korea Cooperation Fund (AKCF) initiated a Training Series – with a view to create more peace and reconciliation experts in the region. The 1<sup>st</sup> Leg of the Training saw **80 participants** – whether diplomats, peace practitioners, educators and representatives from civil society from ASEAN Member States (including Members of the GC, AB & AWPR) – gathering to discuss the challenges and best practices in mediation within a peace and reconciliation context. Amongst the distinguished roster of resource persons were Former Minister for Foreign Affairs of Indonesia, H.E. Hassan Wirajuda, and former Presidential Adviser on the Peace Process and Chair of the Government Peace Negotiating Panel in Talk with the Moro Islamic Liberation Front (MILF), Gen. Eduardo Ermita (Ret.).

The 2<sup>nd</sup> Leg of the Training is planned to be held at the end of 2020 in Myanmar, while the 3<sup>rd</sup> Leg is scheduled to be conducted in the Lao PDR on 2021.

### First Meeting of the ASEAN Women for Peace Registry



22 August 2019 - Phnom Penh, Cambodia

The ASEAN Women for Peace Registry (AWPR) held its very first Meeting, which was facilitated by the Executive Director of ASEAN-IPR. The Meeting was held on the side



of the “Regional Symposium on Implementing Women, Peace and Security Agenda in ASEAN”. The Meeting was an opportunity for Members of the Registry to get to know each other better and understand better their Terms of Reference (TOR) – which was adopted by the Governing Council at the 15<sup>th</sup> Meeting of the Governing Council on May 9, 2019. During the Meeting, Members of the Registry also discussed on their direction and priorities – namely on how the AWPR sees their roles in supporting the ASEAN-IPR and ASEAN through their expertise and activities. Also present during the Meeting was H.E. Elizabeth P. Buensuceso, former Representative of the Philippines to the GC who initiated the Registry, and provided her insights on the vision and endeavour on the AWPR’s establishment. The Meeting decided to have a follow-up meeting among others to have a common understanding of the Leader’s Joint Statement on Women Peace and Security. The Meeting was convened with funding support of ASEAN-US PROSPECT.

### ASEAN-IPR Study Visit on ‘Peace Facilitation and Reconciliation’



12-14 June 2019 - Switzerland

The year 2019 also saw the convening of the Institute’s first Study Visit, upon invitation by the Swiss Federal Department of Foreign Affairs (FDFA), Human Security Division, under the ASEAN-Switzerland Sectoral Dialogue Partnership. The Study Visit aimed to introduce the Institute to the Swiss government and non-governmental organisations (NGOs), as well as to share experiences, lessons learned and best practices on peace facilitation – in support of the Institute’s research, capacity building and pool of expertise functions. ASEAN-IPR Delegation, led by H.E. Arjaree Sriratanaban (Ambassador attached to the Ministry of Foreign Affairs of Thailand, on behalf of the Chair of GC) included Members of the GC, AB, as well as the ED and ASEAN-IPR Secretariat Staff. Throughout the three-day Study Visit, the ASEAN-IPR Delegation touched base with the Swiss government (including the FDFA and the Swiss Parliament) as well as Swiss-based NGOs (such as swisspeace, the Geneva Centres at the *Maison de la Paix*, and the International Committee of the Red



Cross and Red Crescent (ICRC)). Amongst the key takeaways and low hanging fruits for possible areas of cooperation were development of training programmes and collaboration on research projects with organisations such as swisspeace and ICRC. The ASEAN-IPR could also look into possibilities of learning further from the Swiss government's extensive experiences and modalities on peace facilitation – for the benefit of the Institute's capacity, and contribution for the ASEAN community-building.



### **Seminar on the Outcome of the ASEAN-IPR Research Project on Lessons Learned from a Process of Conflict Resolution between the Government of the Republic of the Philippines (GRP) and the Moro National Liberational Front (MNLF), as Mediated by Indonesia 1993-1996**

*23 September 2019 - ASEAN Secretariat, Jakarta, Indonesia*

The very first Research Project for ASEAN-IPR came to conclusion with the Seminar to launch the research findings, which was officiated by H.E. Dr. A.M. Fachir, Vice Minister for Foreign Affairs of Indonesia 2014-2019. The Seminar attracted more than **100 participants** to learn some of the lessons learned from the research, among others: (i) nurture the human factor in peace negotiations; (ii) ceasefires/cessation of hostilities are necessary to hear the voice of reason; (iii) never underestimate opposition/resistance to the negotiation process; (iv) keep communication flowing, to prevent speculations that could do harm to the process; (v) seek facilitation/mediation, if necessary; (vi) engage in diplomacy; (vii) always consider the voice and aspirations of the people/communities. Moreover, participants also got to witness first-hand stories and lessons learned shared by key players in the 1993-1996 peace process, including H.E. Hassan Wirajuda, Atty. Nabil Alfrad Tan (Member of the GRP Negotiating Panel), and Mr. Muslimin Sema (Former Chair of the MNLF 2008-2017). The research also underlined a best practice that could be shared is that an ASEAN Member State gives its trust to another ASEAN



Member State in addressing and resolving its internal conflict, through various methods of informality and flexibility in the process. A publication of the lessons as the outcome of research is available for public on the ASEAN-IPR Website.

### ASEAN Women Interfaith Dialogue: Promoting Understanding and Inclusivity

12-14 November 2019 - Jakarta, Indonesia

Following up to the launch of the AWPR, and pursuant to the ASEAN Leaders' Joint Statement on Women, Peace and Security, a first ever Interfaith Dialogue of women of ASEAN with more than **50 participants** from across the region was convened. The activity was **spearheaded by Indonesia**, with the support from the Government of Australia, the Asia Foundation and the Government of New Zealand. The Dialogue aimed to amplify the voices and participation of women to promote culture of peace, as well as increase the recognition and/or involvement of women in peace processes in the region and beyond. The Dialogue was officiated by a video message from the Minister for Foreign Affairs of Indonesia, H.E. Retno Marsudi, and was graced by the presence of the Secretary-General of ASEAN, H.E. Dato' Lim Jock Hoi. The two-day activity brought together women coming from the diplomatic corps (ASEAN Member States, ASEAN's partners), academes & think tanks, civil society (including faith-based organisations, religious communities, etc.) as well as the media. Issues such as *women empowerment, involvement and inclusion in ASEAN, challenges affecting societal cohesiveness through communities' initiatives, diversity and inclusivity as potential non-traditional threats, and effects of the media and community disclosure.*





A list of recommendations was also suggested collectively by participants, in which ASEAN Member States could take up to address gender-sensitive approaches and empower the roles of women in peace processes.

Some of the recommendations that transpired from the Dialogue among others are (i) to adopt local approaches and languages for promoting inter faith dialogue, especially initiated by women. All stakeholders at the local level need to be involved, especially women and youth in shaping and implementing specific measures; (ii) Promote greater collaboration across the region in promoting gender equality, tolerance, religious harmony, and media literacy in countering conflict and violent extremism; and (iii) for AWPR to conduct a workshop to determine AWPR's priorities and the WPS agenda.

## ASEAN-IPR Communications Strategy and Work Plan

The Communication Strategy and Work Plan were formulated to promote and amplify public awareness of the Institute.

The overall objective of the Communication Strategy was to reach the peoples of ASEAN Member States, to raise awareness of and promote ASEAN's efforts in the areas of peace and reconciliation. The Communication Strategy was designed with valuable insights and inputs from the Institute's Advisory Board.

The Communication Work Plan was then designed to follow the Communication Strategy – where the target audience, objectives & key messages, strategies as well as substantive content (materials) have been clearly laid out. Both the ASEAN-IPR Communication Strategy and Work Plan were approved by the GC on during its 16<sup>th</sup> Meeting on 19 August 2019.

## Update on the Performance of the ASEAN-IPR Website and Social Media Platforms


The ASEAN-IPR Website and Social Media Platforms were developed to support the objectives and work of the Institute, namely in pursuit of its function to network, outreach and disseminate information to stakeholders. The Website Project was developed with the support of the Norwegian Ministry of Foreign Affairs (MFA) through the Norwegian ASEAN Regional Integration Programme (NARIP). The Norwegian MFA support continues with the Website's maintenance throughout 2019, including search engine optimisation (SEO) – which provides a boost for the Website on search engines using keywords such as “ASEAN Institute for Peace and Reconciliation”, “ASEAN-IPR”, “AIPR” and “ASEAN AIPR”.

The number of hits on the ASEAN-IPR Website has almost doubled from the last reporting period, with a cumulative number of **5,074 visits** since its launch in August 2018 (an increase of 2,409 from the last Annual Report). Statistics show that Indonesia, and Jakarta in particular, are on top of the Website's visitors' list.

On the Social Media platforms, the Institute has launched a YouTube channel – to provide more





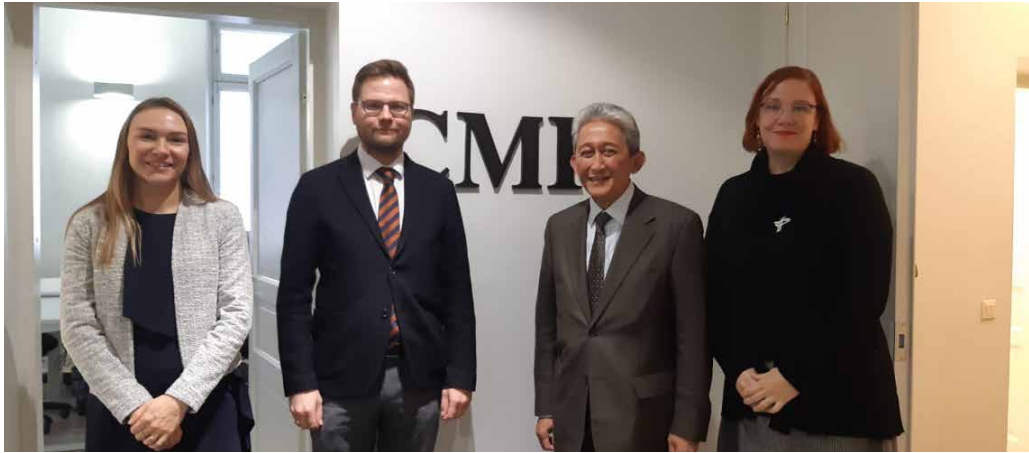
Following the launch of the ASEAN Women for Peace Registry (AWPR) in December 2018, it has garnered significant attention and recognition from stakeholders from ASEAN and outside of the region. On the side of the UN General Assembly, on 26 September 2019, Ms. Moe Thuzar (Member of AWPR, Singapore), represented the Registry at the Launch of the Global Alliance of Regional Women Mediators' Network in New York. She had the opportunity to introduce the AWPR, and engaged with similar regional groupings of women, with a view to collaborate in addressing similar challenges, and moving forward with the AWPR's objectives.

At the end of the year in December 2019 in Hanoi, Viet Nam, the Seventh ASEAN-UN Workshop: 5<sup>th</sup> Regional Dialogue on Political-Security Cooperation (AURED V) was convened, under the framework of the ASEAN-UN Comprehensive Partnership (2011), and the Plan of Action 2016-2020. The AURED V took on the topic 'Focused Collaboration in Support of the ASEAN-IPR', with the overall objective share expertise in developing 'pool of experts'. The Secretary-General of ASEAN and the Assistant Secretary-General of the UN for Political and Peacebuilding Affairs and Peace Operations were amongst the distinguished attendees, in addition to two former Secretaries-General of ASEAN (H.E. Ong Keng Yong (Singapore) & H.E. Le Luong Minh (Viet Nam)) as panellists, as well as Members of the GC, AB & AWPR as active participants.

Throughout the years, the ASEAN-IPR Secretariat has also had the pleasure of receiving, engaging and briefing students, junior diplomats, government officials from outside of ASEAN, and other stakeholders on the work of the Institute.

## Terms of Reference of the ASEAN Institute for Peace and Reconciliation

---

The ASEAN Institute for Peace and Reconciliation (hereinafter referred to as ‘the Institute’) shall be established under Provision B.2.2.i of the ASEAN Political-Security Community Blueprint. As a follow-up to the ASEAN Leaders’ Joint Statement on the Establishment of an ASEAN Institute for Peace and Reconciliation adopted on 8 May 2011, the Institute shall be an entity associated with ASEAN under Article 16 of the ASEAN Charter.

The Institute shall operate in accordance with the following Terms of Reference (ToR):

### 1 HEADQUARTERS

The headquarters of the Institute shall be in the Republic of Indonesia, hereinafter referred to as “the Host Country”, and shall be based in Jakarta.

### 2 LEGAL PERSONALITY

The legal personality of the Institute shall be established under a Memorandum of Understanding (MoU) between the Host Country and the Institute.

### 3 PRINCIPLES

The Institute would operate in accordance with the ASEAN Charter and be guided by the principles of the Treaty of Amity and Cooperation in Southeast Asia, *inter alia*:

1. respect for the independence, sovereignty, equality, territorial integrity and national identity of all ASEAN Member States;
2. shared commitment and collective responsibility in enhancing regional peace, security and prosperity; and
3. non-interference in the internal affairs of ASEAN Member States.

### 4 MANDATE AND FUNCTIONS

#### 4.1 Mandate

The Institute shall be the ASEAN institution for research activities on peace, conflict management and conflict resolution, as requested by ASEAN Member States.

The Institute’s work will include, *inter alia*, promotion of those activities agreed in

the ASEAN Political-Security Community Blueprint and additional activities as agreed by ASEAN Member States.

#### 4.1 Functions

The Institute may undertake, among others, the following activities:

##### ■ Research

- Undertake research and compile ASEAN's experiences and best practices on peace, conflict management and conflict resolution as well as post-conflict peace-building, with the view to providing appropriate recommendations, upon request by ASEAN Member States, to ASEAN bodies
- Undertake studies to promote gender mainstreaming in peace building, peace process and conflict resolution
- Study and analyse existing dispute settlement mechanisms in ASEAN with a view to enhancing regional mechanisms for the pacific settlement of disputes

##### ■ Capacity Building

- Hold workshops on peace, conflict management, conflict resolution
- Hold seminars/workshops/training in promoting the voice of moderation to contribute to the Global Movement of the Moderates, as well as to advance work in the area of interfaith dialogue
- Knowledge building among relevant government officials, scholars or think-tanks on conflict management and resolution

##### ■ Pool of Expertise and Support for ASEAN Bodies

- Develop a pool of experts from ASEAN Member States as resource persons to assist in conflict management and conflict resolution activities
- Where appropriate and at the request of ASEAN governments, provide policy recommendations to ASEAN governments on promotion of peace and reconciliation based on their own studies, as well as facilitation for peace negotiation
- Assist ASEAN bodies, upon request of ASEAN Member States, on activities and initiatives related to peace, reconciliation, conflict management and conflict resolution

### ■ Networking

- Function as a knowledge hub by establishing linkages/network with relevant institutions and organisations in ASEAN Member States, as well as other regions and at the international level, which have similar objectives aimed at promoting a culture of peace
- Collaborate with relevant UN agencies, regional organisations and international think tanks to exchange expertise and experiences on peace, conflict management, conflict resolution

### ■ Dissemination of information

- Disseminate best practices, lessons learned and relevant information to ASEAN Member States
- Outreach and engagement with the civil society and other relevant stakeholders to promote peace, reconciliation, conflict management, conflict resolution and peace-building
- Promote awareness of the work of the Institute among the general public

## 5 BUDGET AND FUNDING

- ASEAN Member States shall make a contribution to support the operations of the Institute for each budget year.
- ASEAN Member States may consider making additional contributions to support the operations of the Institute within the same budget year.
- The Institute may seek additional project-based voluntary funding from ASEAN Member States on an ad hoc basis, which should be requested in a timely manner
- The Institute shall mobilise additional resources from ASEAN Dialogue Partners, interested countries, international and regional organizations, financial and any other institutions, corporations, foundations or individuals to fund project-based activities.
- The resources mobilised to fund the project-based activities will also be allocated as deemed appropriate to support the operations of the Institute.

## 6 STRUCTURE

The Institute shall be composed of the Governing Council, the Executive Director and an Advisory Board

### Governing Council

- The Governing Council, here in after referred to as “the Council”, shall consist of :

- a Representative of each ASEAN Member State to be appointed by and accountable to the respective appointing Governments;
  - the Secretary-General of ASEAN as ex-officio member; and
  - the Executive Director as ex-officio member.
- Each Member of the Council, except for the ex-officio members, shall work for a term of three (3) years and shall be eligible for one re-appointment.
  - The Chair of the Council shall be the Representative of the ASEAN Member State holding the Chairmanship of ASEAN.
  - The Members of the Council, except for the ex-officio members, shall elect two (2) Vice-Chairmen from among themselves each for a term of one year.
  - The Council shall :
    - formulate the guidelines and procedures for the activities of the Institute;
    - have the overall responsibility for the funds of the Institute and shall be responsible for the formulation of policy for the procurement and the utilization of the funds;
    - approve the annual operating budget for the Institute;
    - perform such other functions as may be necessary to carry out the objectives of the Institute; and
    - meet at least twice a year.

### Executive Director

- The Executive Director of the Institute shall be a national of an ASEAN Member State and shall be appointed by the Governing Council through open recruitment for a non-renewable term of three years.
- The Executive Director in discharging his/her functions to serve ASEAN Member States, shall represent the Institute, not his/her country or any other institution.
- The Executive Director shall:
  - represent the Institute in all administrative and operational matters, manage the activities of the Institute and perform such other functions as may be assigned by the Council from time to time;
  - have authority to appoint such professional, secretarial and administrative staff as are necessary to achieve the Institute's objectives; and
  - undertake activities to raise funds for the Institute's activities, in accordance with guidelines and procedures as established by the Council.

- The Executive Director shall be responsible to the Council.

### Advisory Board

- An Advisory Board, hereinafter referred to as “the Board”, shall consist of:
  - a representative appointed by the government of each ASEAN Member State, here in after collectively referred to as “Representative”;
  - the Executive Director as ex-officio member.
- Representatives shall work for a term of three years and shall be eligible for one re-appointment.
- Representatives shall be eminent persons in the field of peace and reconciliation, including, but not limited to, academics, parliamentarians, senior or retired civil servants and civil society representatives.
- Representatives on the Board, with the exception of the Executive Director, shall not serve concurrently on the Council.
- The Board shall advise the Council on the research priorities for the Institute.

## 7 DECISION-MAKING

Decision-making in the Institute shall be based on consultation and consensus in accordance with Article 20 of the ASEAN Charter.

## 8 REPORTING MECHANISM

The Executive Director shall make regular reports on the work of the Institute through the relevant senior officials to the ASEAN Political-Security Community Council (APSC Council).

## 9 REVIEW MECHANISM

This TOR shall be initially reviewed five years after the official launching of the Institute. This review and subsequent reviews shall be undertaken by the APSC Council supported by the relevant senior officials.

## Three-Year Work Plan of the ASEAN Institute for Peace and Reconciliation (ASEAN-IPR) 2018 – 2020

### Objective of the Three-Year Work Plan of ASEAN-IPR

Pursuant to its Terms of Reference (TOR), the ASEAN Institute for Peace and Reconciliation (ASEAN-IPR) would operate in accordance with the ASEAN Charter, and be guided by the principles of the Treaty of Amity and Cooperation in Southeast Asia (TAC). ASEAN-IPR holds the mandate to be the ASEAN institution for research activities on peace, conflict management and conflict resolution, as well as to promote activities agreed in the ASEAN Political Security Community (APSC) Blueprint and additional activities as agreed by ASEAN Member States (AMS).

On 1 November 2017, the Executive Director (ED) of ASEAN-IPR submitted his '90-Days Priorities' to the Governing Council (GC), which includes the formulation of Three-Year Work Plan of the Institute. The overall objective is to realise the mandates and functions of the Institute – as stipulated in its TOR, with a view to work towards provisions in the ASEAN Political-Security Community Blueprint on conflict resolution and pacific settlement of disputes as well as post-conflict peace-building which aimed at the creation of cohesive, peaceful and resilient region with shared responsibility for a comprehensive security.

Therefore, the Three-Year Work Plan of ASEAN-IPR is formulated with reference to the TOR, the APSC Blueprint 2025, and other ASEAN documents relevant to the work of ASEAN-IPR, guided by the ASEAN Charter, TAC and decisions of the GC.

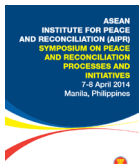

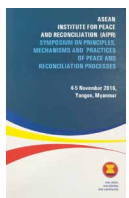

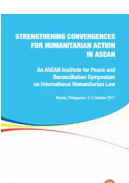
